Flag football team ends season with 16-12 win

Piedmont High's flag football team concluded its season on a high note, defeating Arroyo 16-12 at the Dons' home field in San Lorenzo on Wednesday, October 23. The Highlanders finished with a 6-10 overall record and 5-8 in league, and did not qualify for the league playoffs.

With 16 points, it marked the first time Piedmont got into the end zone more than once in six

games since a 13-12 win over Mt. Eden on October 2. Finishing drives was an emphasis by coach Beth Black, who had the squad do postgame pushups for missed scoring chances. "We had them do pushups for

the passes we dropped in the end zone. We're going to find any way to get better. We did well executing some new looks and it panned out today," Black said.

The Highlanders' defense has kept them in games throughout the season. Despite finishing 6-10, the defense held teams to two touchdowns or less in eight games this season.

"I feel like one reason we've been clicking was a lot of our defense were returning players. We trust each other and know if I miss a tackle, I have someone to back me up," junior defensive back Dahlia Osman said.

We talk a lot and make sure everyone is on the same page and to always attack the football," senior leader Mary Schickedanz

Both Schickedanz and Osman recorded critical interceptions against Arroyo to halt drives. Osman had two interceptions including returning a pick to the one-yard line, while Schickedanz notched her second pick-6 of the

"There were a couple of plays where they really floated the ball. I saw the ball and knew I could get it.," Schickedanz said of her interception.

In looking ahead to 2025, Piedmont will have to replace much of the current lineup with eight graduating players. However, they will bring back several key players, includinge Osman, pass rusher Elspeth Grippando, quarterback Edie Elmquist, and will call up speedy JV running back Riley Burton.

Game Recap

Piedmont led 8-0 through the first half and scored early in the second half to take a 16-0 lead with both of PHS' being successful on its pair of two-point conversion tries. Arroyo two touchdowns from there, but it wasn't enough to overtake the Highlanders.

In the first half, Arroyo took the opening possession all the way down to Piedmont's onevard line-where Osman made a critical tackle right before a Dons' receiver crossed the goal line. On the Highlanders' ensuing possession, they drove down to the Arroyo eight with help from a big 24 yard reception by Malia

SAM SHELBY

Shelby has consistently been a main part of Piedmont's offense, helping them build an 8-1 record entering the final game of the regular season. In four games in October, Shelby totaled 21 receptions for 432 receiving yards, 87 rushing yards, and six touchdowns. His best performances was nine receptions for 193 yards and two touchdowns in a win on October 4 over Dougherty Valley. He also had five pass receptions for 148 yards and three touchdowns on October 25 against Washington.

MEI ASSALIAN

Assalian will graduate from Piedmont High as perhaps the program's best golfer in the last decade. At the Antioch Invitational on October 14, she finished third of 37 athletes with 81 strokes, helping Piedmont finish second of seven schools. Then at the WACC Tournament at Monarch Bay on October 21, Assalian shot an 87 to help PHS finish se ond overall. She qualified for the Div. 2 North Coast Section championship, and placed 13th of 144 athletes at Rooster Run in Santa Rosa on October 28 with an 82

ELLES KREICKHAUS

Elles Kreickhaus has been a key member of the water polo team achieving a 15-9 record as it enters the NCS Tournament. He scored 15 goals in four games at the Monterey Invitational on October 4-5, and was part of Piedmont's recent 14-9 win over rival Bishop O'Dowd in the first round of the WACC Tournament on October 28. In a dominant performance, he scored six goals and had three assists.

LEIGHTON MAND

Mand, a sophomore, earns an honorable mention for leading the girls' cross-country team in several meets in October. She led PHS to the team championship at the Artichoke Invitational at Half Moon Bay, where she placed 11th in a field of 159 runners and posted a time of 15:29. At the Mariner Invitational at Hayward High, she led the team and was 43rd of 188 runners in 19:38.57.

After forcing a turnover on downs at the Arroyo 34, Piedmont gained 1st-and-Goal at the 12, but tossed an interception in the end zone. On the Dons' next drive, Osman snatched an interception and returned it nearly 40 yards to the Arroyo one. The Highlanders then broke the deadlock on 2nd-and-Goal on a quick pass to Nemeth with 4:27 left. Elmquist then found Osman on a short pass for the two-point conversion, 8-0.

Both teams traded possession until the end of the half. Then at the start of the second half, Piedmont's defense forced a 4th-and-4 at the Arroyo 36 when Schickedanz jumped on pass to take an interception all the way to the end zone for a touchdown at the 21:55 mark of the second half. Miya Fujimoto then reeled in a catch for the two-point conversion, making it 16-0.

ter of the film. While the preparations upstairs and downstairs are vastly different, the fact of a royal visit is breathtaking news requiring much organization. There are protocols to be followed, endless arrangements to be made, and much discussion to be had. Plus, suddenly there is no hot water -aboiler problem, it seems.

So important is this visit, the Granthams call up their much relied upon head butler, Carson (Jim Carter), to take charge. He is a man of tradition and stature who is deeply pleased to briefly abandon his retirement and take familiar walk up to the house

A source of tension arises when it's learned that the royals will be arriving with their own chef and maids and butlers. Much to the chagrin of Downton's staff, who to a person take their service very seriously. But they have a plan which is both audacious and proves to be successful.

It's all gorgeous and wonderful. Houses such as Downton Abbey were houses divided, but those working upstairs and those down were not divided – at least not in this household. Each, in their own way, took pride in their roles and service. All were decent to a fault, even when mini-dramas erupted upstairs and were quietly solved in conversation in one of the fabulously appointed rooms.

Downton Abbey is a soufflé of a movie – a beautiful, soapy glimpse into England in early 20th century. To the writers' credit, there was never a hint of bias or prejudice regarding who worked downstairs and who lived upstairs: all seemed grounded in their own way.

I must say that the dress of the family upstairs was spectacular, with a spectrum of colors featuring burnt coral and cloud white and lush pink - and with beads and tiaras plus tweed and flannel by the yard. All a wonderful, quick glance into a life now all but gone.
